

In research by Costas (2018), g and h are mutual complete. "Current research suggests that these indexes do not substitute for each other but that they are complementary".




Figure 2. Network Visualization Cluster Study about BPK Audit Opinion (Source: Analysis through application VoSViewer)





Figure 3. *Density* Study of BPK Audit Opinion (Source : Analysis through application VoSViewer)
